Applications are invited from experienced certified energy auditors (CEA) for empanelment of as an "**Urja Mitra**" for MSME Clusters indicated at **Annexure-II** on honorarium, initially for a period of one year (01) extendable for a maximum period of two years (02) subject to satisfactory performance on monthly activities indicated at **Annexure-III**.

Urja Mitra in MSME Clusters:

In order to have a continuous presence in the cluster, the empanelment of experienced CEA as "Urja Mitra" will act as a focal member for promoting energy efficiency and renewable energy in the cluster and be the interface between bureau and the stakeholders in the cluster. Experts in energy efficiency and industrial processes and technology. Skilled in industrial sectors and energy conservation, commendable knowledge of current developments in energy transition and industrial transformation.

Urja Mitra, will provide advisory services & industrial diagnostic studies in the cluster. The services include assistance for unlocking energy efficiency and energy saving potentials assessments, introducing energy management systems to the stakeholders, support on technology identifications, technology implementation, and developing technology demand aggregations, compile list of case studies co-ordinate with the bureau and SDA as when required.

About Energy Clinics:

"Energy Clinics" illustratively a small base camps to be established temporary at SME clusters by Urja Mitra. The objective of the clinical establishments is to provide industrial diagnostic studies for the SME units in the cluster. These establishments may be placed with-in the office of local association or local industrial bodies (MSME-DIs, TCs etc), where stakeholders may take consultations.

Roles and Responsibilities:

The designate will be empanelled by BEE, who will foresee the implementation of desired project objectives and services to the SMEs in the selected cluster. Following are the broad responsibilities of Urja Mitra,

- Promote energy efficiency and renewable energy in the cluster.
- Co-ordinate with BEE and SDA for any local level activities.
- Outreach all the SMEs in the cluster of the focused sector and establish policy focused relations in the cluster.
- Establish weekly camp at various locations in the cluster for technology/energy efficiency service.
- Visit industries for primary data collections, conducting walk through audits, preparation of pre-detail audit case studies.
- Develop technology and vendor database.
- Collect expression of interests from the SME units for various services (conducting detail energy audits, technology and EE measures implementations, vendor interfacing, Processing for loan facilities)
- Develop comprehensive database of resources, activities in the cluster.
- The designate Urja Mitra will report to SDA in the form of monthly deliverables (format attached)
- Manage all the publishing activities as per directions

Note: All the Urja Mitra should manage their own IT facility. BEE will call for monthly review meeting through virtual mode. The Urja Mitra should also be available on demand for any urgent/immediate matters whenever required.

Age, educational qualification and experience required :-

- a. Minimum age will be 30 years as on 1.1.2023.
- b. Education Qualification
 - i. B. E/B. Tech or M. Tech
 - ii. BEE Certified Energy Auditor
- c. 5 Years or more experience post certification of CEA.
- d. Sector specific experience will be needed for 1 year.
- e. Conducted at least 5 Detail Energy Audits for Industrial Establishments/SMEs.
- f. Experiences in energy efficiency related project implementation/demonstration will be preferred.
