Eligibility Criteria and Terms & Conditions

- 1. Sealed Limited Tender are invited by the Bureau of Energy Efficiency (BEE) for supply of Ten (10) "i5 Laptops" of reputed brands of HP and DELL with preloaded original operating system as per the specification given at **Annexure-II**.
- 2. Bids in sealed cover super scribing the envelop "Bid for supply of i5 Laptop" addressed to the Secretary, Bureau of Energy Efficiency, 4th Floor, Sewa Bhawan, R.K. Puram, New Delhi 110066 latest by 1500 hrs. 10th June, 2019 which will be opened on the same day at 1530 hrs. in Conference Room of BEE in the presence of interested bidders or their representatives. All bids shall remain valid for acceptance for a period for 120 days from the date of opening of bids. Incomplete bids shall be liable to be rejected.
- 3. The bidders should be authorised vendor of Original Equipment Manufacturer (OEM) in India.

- 16. The BEE reserves the right to accept or reject summarily any or all quotations in whole or in part without assigning any reason whatsoever.
- 17. The BEE takes no responsibility for delay, loss or non-receipt of bids after dispatch.
- 18. In case of any dispute or differences, the same shall be settled by reference to the sole arbitration of the DG, BEE or other officer appointed by DG, BEE. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act, 1996. There will be no objection to any such appointment on the ground that which the agreement relates or that in the course of his duties as a Government Servant employee he has expressed his views on all or any of the matters in dispute. The award of the arbitrator shall be final and binding on both the parties to the agreement.
